GENERAL INFORMATION

The journal "EUROPEAN VECTOR" is a scientific-practical publication, published under coordination of the Editorial Board in accordance with the Rules of Publishing and Dissemination of the Journal , approved by the USEM Senate (Report no. 2 of 30.10.2017).

The journal is published by the USEM Editorial Complex.

The journal serves as quality platform for scientific discussions, launched by USEM researchers, and also gives possibility to test young researchers capacities - PhD students, master students within USEM as well as from other university centers in the country and abroad.

The editorial activity is coordinated by the Editorial Board and the Editor-in-Chief.

The articles are presented to the editors of the "EUROPEAN VECTOR" Journal in languages:

Romanian, Russian, English and French and will follow the general rules of writing and editing, established by the Editorial Board, reflected in the Publishing and Dissemination Regulations of the Journal.

The purpose of the journal is to publish the scientific results obtained by the teaching staff of USEM and other contributors to the Journal , expanding editorial relations with others institutions in the country and abroad, as well as informing the university community about scientific innovations in the fields of: legal sciences, economics and psychology.

The journal was founded in 2013, and it is published with a periodicity of 2-3 issues annually.

REQUIREMENTS FOR AUTHORS

The journal is published by the USEM Editorial Complex. According to the Regulation of editing and dissemination of the Journal, approved by the USEM Senate (Report no. 2 of 30.10.2017), the publication of scientific articles is free of charge. Authors are not remunerated for materials entrusted to the journal for publication.

The authors assume responsibility for the authenticity of the published manuscripts and assign them to the journal the right to publish exclusively.

The editorial activity is coordinated by the Editorial Board and the Editor-in-Chief.

The articles are presented to the editorial staff of the "Vector European" Journal in Romanian, Russian, English and French and will follow the general rules of writing and editing, established by the Editorial Board, reflected in the Regulations for publishing and disseminating the Journal.

The journal appears in printed and electronic format with the code ISSN 2345-1106 and E-ISSN 2587-358X.

The editorial board selects reviews from a pre-developed database.

Authors should meet the criteria set out in the Regulation of evaluation, classification and monitoring of scientific journals approved by the Decision of the Governing Board ANACEC no. 6 of December 18, 2018 and the Guide for writing the thesis of PhD doctor / doctor habilitat, approved by the Decision of the Governing Board of ANACEC no. 5 of December 19, 2018.

Article structure:

1. **The title of the article** (TIMES NEW ROMAN, Bold, 12 pt, centered) should be submitted in Romanian or Russian (the language of writing the article) and English) - one line away from title indicates the author / authors.

2. **Author of the article or Authors:** The name and surname of the authors will be written as follows: **TNR 12**, bold, left-aligned, first name in lower letters followed by the author's surname with capital letters.

After that, write the degree and the scientific-didactic title and the functions of the authors. Indicate the author's email to carry the correspondence

3. The scientific article is presented in **Romanian** or in **English**. As exception articles can be presented in other languages (Russian, French, German, etc.) having abstracts in English and Romanian (or Russian if the language of the article is Russian).

4. **Summary:** (Summary: / Аннотация :) (Times New Roman, 12 pt, italics, 300 signs, in Romanian (or Russian if the language of the article is Russian) and English);

5. **Keywords:** (Keywords: / Ключевые слова :) - (Times New Roman, 12 pt, italics, maximum 5-8 representative words, in Romanian (or Russian if the language of writing the article is Russian) and English);

6. **The text** must include the following parts:

The introduction will summarize the need for research, arguing scientifically their opportunity. References will be made to the main information and results of research in the field, quoting in square brackets the number of the author (s) studied, so

as it appears in the bibliography at the end of the paper;

- **Materials and methods** (for the socio-humanities it is indicated in case of need);
- **Results and discussions** - the main content of the paper in which will be presented the results obtained from the research, in logical succession to allow the reader to interpret the data correctly. The presentation of significant results must be accompanied by discussions, comments referring to their scientific interpretation. Comparisons will be made with the results obtained by other authors from the studied literature.
- **Conclusions** - The main ideas, conclusions, proposals, recommendations, etc. which are important findings from research;
- **Bibliographic references: (Bibliographic references: Библиографические сноски :)**

is placed at the end of the article in alphabetical order (Name, first name, title, publisher, year, pages - Times New Roman, 12, aligned left). Bibliographic references will be indicated in the text (eg. [5, p.75]).

The text will be written with:

- Characters - Times New Roman; 12 pt; interval - 1.0;

Paper size: A4 210 x 297 mm, Margins: top - 20 mm, bottom - 20 mm, left - 20 mm, right - 20 mm, aligned - 100 mm.

- The presented scientific paper will contain **6-8 pages A4**.

If the paper is larger (up to 20 pages) it will be published as a study attributing to the category of synthesis article or studies.

- **The graphic elements (tables and figures)** will be placed, directly, according to the respective reference in text. All items must be accompanied by a **title and serial number** (above table, below the figure), **source** and, if necessary, **additional information**: notes, legend elements). Only high quality scanned figures are allowed. **When the graphic elements are included in the paper, authors are asked to take into account the editing format of the journal.**

IMPORTANT: Works that do not follow the editing instructions will not be published.

The **Review** is written in Romanian (Russian) and is accompanied by the reviewer 's signature (with scientific degree of doctor habilitat, PhD doctor, associate professor (docent), and the stamp. It is sent electronically together with the article.

The Editorial Board assumes responsibility and the right to appeal to another reviewer.

The manuscript of the article is not returned
